CITY COUNCIL CORNER

Each month we will keep you informed of the City Council decisions from the previous month. In May:



- Approved a business license for Millville Firearms as requested by Matthew Anderson at 211 South 300 East.
- Approved the Iverson Minor Subdivision located north of Center Street and west of 100 West.
- Reviewed the proposed budget for fiscal year 2011 and set a public hearing for June 10, 2010.
- Approved the Interlocal agreements for Police Service and Animal Control with the Cache County Sheriff's Department.
- Adopted Ordinance 2010-2 Revision to City Council Ordinance in the Millville City Code regarding Council Meeting Time, Place; Exceptions:.
- Acknowledged receiving a \$35,000 grant from the County RAPZ monies for a new pavilion to be built on the north side of the City Park.
- Reviewed animal control concerns, licensing, and citations for dogs running at large.
- Approved a business license for Hoth Enterprises at 195 North 250 East to sell security systems as requested by Colten Hoth.
- Reviewed the revised budget for fiscal year 2010 and set the public hearing for June 10, 2010.
- Set a public hearing for June 10, 2010 to receive input on revisions to the Millville City Code deleting the chapter regarding Home Occupations, Ordinance 17.48; also Revising the Administrative Reviews and Permit Processing regarding Sign Permits, Ordinance 17.80.020.
- Continued planning for the Sesquicentennial Celebration held on June 12, 2010.
